


# OFFICER ACTIVITY STATISTICS (Calls by Jurisdiction)







#### SHELTER NOTES

Beginning September 1<sup>st</sup>, 2018 our new Owner Surrender Policy was instituted at Montgomery County Animal Care and Control. The below figures will represent the number of pets that were owner surrendered and their subsequent outcome after being surrendered to the shelter. This number does not represent the number of pets that are diverted from entering the shelter.



#### SHELTER NOTES

Beginning on September 1<sup>st</sup>, 2018, Montgomery County Animal Care and Control instituted a new policy requiring all dogs and cats that are adopted or reclaimed at our facility must be implanted with a microchip tracking device.



#### SHELTER NOTES

Beginning September 1<sup>st</sup>, 2018 we will be instituting the new Owner Surrender Policy and mandatory microchipping through the shelter. The figures below represent a running total from January 1<sup>st</sup>, 2018 to July 31<sup>st</sup> 2018. We will be running a month to month comparison to the 2017 figures at the conclusion of this calendar year.
