In accordance with Montgomery County Animal Control Regulations, animals are determined to be dangerous under the following guidelines. The full set of regulations and definitions can be viewed at montgomerycountyttn.org click department tab, animal control.

1. Infliction of a bite upon a person either on public or private property.
2. Killing or inflicting severe injury upon a domesticated animal or attacking livestock when not on its owner's property.
3. Approaching a person when not on its owner's property in a vicious or terrorizing manner demonstrating an apparent attitude of attack.

Infliction of a bite while off the owner's property

Child went to owner's door to inform them their dog was loose resulting in dog attacking causing several punctures

Attacked neighbors poodle while off the owner's property, resulting in bite while breaking up attack

415 Alabama Ave. "Precious" Pitt
Attacked neighbors cat while off the owner's property resulting in bite when trying to save cat

956 Granny White Dr. "Country", Pitt
Charged children walking to school in a vicious or terrorizing manner demonstrating an apparent attitude of attack, to include the animal control officer and police officer upon arrival

Attacked 2 animals while off the owners property

Owner unable to contain, resulting in dog breaking loose and biting an individual walking by

Infliction of bite upon a child

138 Dave Dr, “Chevy”, Pitt mix

Infliction of bite upon a person while off the owners property

Infliction of bite while off the owners property
Charging a person aggressively in an apparent manner of attack

“Tip” Pitt, infliction of a bite upon a person while off the owner’s property
“Trea” Approaching people in a vicious or terrorizing manner demonstrating an apparent attitude of attack while off the owner’s property

123 Brandywine Dr., “Kayla” Lab-Pitt mix, tan
Attacked neighbors dog resulting in death of animal, while off the owner’ property

1611 Woodlawn Rd., “Ravage” Black Pitt w/white chest/paws
Attacked neighbor’s dog while at large resulting in serious injury, (Lung puncture, bite punctures)
